

TERMS AND CONDITIONS - Dress Like a Sport Fan Competition

1. **Promoter** - This competition is promoted by Weskus Mall ("the Promoter").
2. **Eligibility** - You may not enter this competition if you are a director, member, partner, employee, tenant, agent, consultant, or supplier of the Promoter, or their respective spouses, partners, immediate family members, business partners, or associates.

4. **Acceptance of Terms** - By entering this competition, participants agree to be bound by these Terms and Conditions.
5. **How to Enter**
 - 5.1 Participants must take a photo in the TikTok Room at Weskus Mall using the Rugby/Soccer-themed background.
 - 5.2 The photo must be uploaded in the comments section of the official competition post on the Weskus Mall Facebook page.
 - 5.3 Participants must tag Weskus Mall in their competition entry. (@WeskusMall)
6. **Competition Period** - The competition opens on **Thursday, 11 June 2026 at 12:00** and closes on **Wednesday, 17 June 2026 at 20:00**. No late entries will be accepted.
7. **Winner Selection** - The winner will be selected on **19 June 2026**.
 - 7.1 Only one (1) winner will be selected, and the decision of the Promoter is final.
 - 7.2 Should any unforeseen circumstance require additional adjudication; the judging panel reserves the right to conduct a random draw to determine the winner.
8. **Prize** - The winner will receive:
 - One (1) Fuel Voucher to the value of **R1,000**, and
 - One (1) Father's Day Hamper to the value of **R2,000**.

The prize is not transferable and may not be exchanged for cash.

9. **Publicity** - The winner may be requested to participate in publicity activities related to the competition, including the use of their name and photograph for promotional purposes. Participation in such publicity is voluntary and may be declined.
10. **Winner Notification** - If the winner is not present at the time of the draw, the Promoter will attempt to contact the winner for a period of seven (7) consecutive days. Should the winner be unreachable, fail to respond, or decline the prize, the prize will be forfeited, and the Promoter reserves the right to select an alternative winner.
